Grant-writing skills in life sciences: A workshop for early- and mid-career researchers

Target group: clinicians (junior and senior) who are writing research funding applications.

Time commitment: 3 live meetings of 2.5 hours each. Access to a set of podcast lectures for self-study (230 mins listening time).

Technology: Zoom for live sessions, Scriptorium website for podcast lectures for self-study following the workshop.

Language of instruction: English.

Quick description. In this workshop, you will learn how to:

- 1. Interpret correctly the application form and evaluation criteria for a scientific research proposal.
- 2. Use strong structure in State of the Art, Objectives, and Methodological Programme: the key scientific sections in any research proposal.
- 3. Develop the Work Plan section using components such as milestones, deliverables, a timeline, and resource justification.
- 4. Present convincingly your academic and clinical CV, drawing on both quantitative and qualitative parameters of excellence. We will use the ERC's 4-page CV & Track record as a case study.

Funding instruments used as case studies: We will use the DFG Benjamin Walter and ERC Starting grant as two case studies. We will also refer to other examples of national and European funding instruments to broaden the relevance of conclusions drawn. If a clinical funding instrument of shared interest can be established, we will integrate it as a third major case study for analysis.

Workshop Structure

Each live meeting will take 2.5 astronomical hours, with a 5-min break in the middle.

Meeting 1: Focus on the proposal structure and analysis of typical evaluation criteria Topic 1: analysis of application forms and evaluation criteria Topic 2: how to structure a classic scientific proposal; variable solutions with different page length

Meeting 2: The "Work Plan" in national funding applications; analysis of examples Topic 1: integrating milestones, deliverables, timelines, and resources justification into a proposal. Topic 2: analysis of open-access examples from European funded grants.

Meeting 3: The candidate evaluation: CV structure and typical evaluation criteria

Topic 1: using quantitative and qualitative descriptions to optimise your profile's presentation in the research CV.

Topic 2: the narrative CV; using a personal or motivation statement as a persuasion tool.
